SUBJECT: VALUE ENGINEER AND CONSTRUCTABILITY-AUTHORIZATION

TO ISSUE A REQUEST FOR PROPOSAL FOR SERVICES

TYPE: ACTION NEEDED

The Facilities Department at the Office of Superintendent of Public Instruction (OSPI) require, as a condition of qualifying for state construction matching funds, that new school construction plans be subjected to a value engineering (VE) and constructability review process. The new Stanwood High School is required to have such a review.

Value engineering is an approach to optimize both cost and performance of a school building. A VE team, composed of architects, engineers, project managers, and others not connected with the project design team (McGranahan Architects), is formed to study the lead architect's plans during the design development phase and make recommendations for potential cost savings and functionality improvements. A constructability review is performed by an independent consultant with the goal of achieving the lowest possible bid and to minimize the chances of change orders and claims after construction begins. Performing a constructability review of design involves reviewing the contract documents and identifying a potential claim or problem areas and deficiencies that may occur during the construction phase of a project. The purpose is to identify errors, ambiguities, omissions, discrepancies, and conflicts in the construction documents. Some firms specializing in this work may be qualified to perform both the VE and constructability study.

The capital projects department will issue a detailed request for proposals and will make a recommendation for board approval. Our plan is to have that recommendation and a request to approve a contract on the September 5, 2017, board agenda. The budget for this work is \$82,190.

We recommend the board <u>move to authorize the issuance of a request for value engineering</u> and constructability services for the new Stanwood High School.
