On November 5, 2013, voters approved the School Facilities and Technology levy. One of the technology projects that are funded by this special levy is the Virtual Desktop Infrastructure (VDI). As we continue the implementation of the Virtual Desktop Infrastructure, this requires additional servers and associated installation equipment.

Attached to this memo is a copy of the proposal # ZDJJQ3911 we are seeking permission to purchase at this time. This pricing is based on the Cisco Prime Contract bid administered by Washington State Department of Enterprise services and Western State Contracting Alliance under Washington WSCA/NASPO Master Agreement #AR233 (14-19).

The total amount of the proposal is \$123,798.90 with tax included, the total of the purchase order to be issued is \$135,064.60.
