SUBJECT: PURCHASE FOR CISCO SERVERS

On November 5, 2013, voters approved the School Facilities and Technology levy. One of the technology projects that are funded by this special levy is the purchase of servers for use within the virtual desktop infrastructure (VDI) within the district. We are about to begin the implementation of greater graphics capacity within the VDI environment.

To further the capacity and performance of the VDI environment, it is necessary to purchase graphics processor technologies that complement our existing VDI servers.

We are seeking approval to purchase Cisco nVidia cards and support for this graphics technology. The cost to utilize the graphics technologies for our existing servers is \$159,853.82.

Recommendation:

We recommend the board move to approve the purchase of graphics technology hardware in the amount of approximately \$160,000.
